In August of 2017, Representative Mimi Walters joined several House republican colleagues in signing a letter to Secretary of the Interior Ryan Zinke, saying: “The United States is in an unique and strong position today because of the abundant oil and natural gas safely produced across the country and off our coasts. Once heavily dependent on foreign sources of energy, our status as an energy superpower not only provides our nation with greater energy security, but also enhances our national security efforts at home and abroad. We applaud your commitment to making the U.S. “energy dominant” and look forward to the development of a new National Outer Continental Shelf Oil and Gas Leasing Program. In the development of this program, it is imperative that we fully consider all OCS lands, including those not part of the current 2017-2022 Program, to ensure opportunities are not missed.” [Letter to Secretary of the Interior Zinke, 8/16/2017]</p>

Walters is with Trump, there too.</p>	<p>Mimi Walters Voted For An Attack on Smog Protections & the Clean Air Act. Representative Pete Olson (R-TX) sponsored H.R. 806, the Ozone Standards Implementation Act of 2017, which would delay the Environmental Protection Agency’s (EPA) recently-updated standards for ozone pollution and eviscerate a central pillar of the Clean Air Act. This legislation would allow the EPA to consider factors unrelated to health, like technical feasibility, in the initial standard setting process. This bill would also delay the EPA’s ozone standards by at least ten years and double the current five-year review periods for updating all national air quality standards, allowing unhealthy air to persist even longer. On July 18, the House approved H.R. 806 by a vote of 229-199. The pro-environment position was NO. Mimi Walters votes YES. [LCV Scorecard, House Vote #391,</p>

		<p>7/18/2017]</p> <p>Mimi Walters Voted To Block Safeguards Against Methane Pollution On Public Lands. Representative Rob Bishop (R-UT) sponsored H.J. Res. 36, the Congressional Review Act "Resolution of Disapproval" of the Methane and Waste Prevention Rule, which would block efforts to reduce dangerous methane pollution released by the oil and gas industry on our public and tribal lands. The Bureau of Land Management's Methane Rule establishes commonsense standards that require oil and gas companies to deploy readily available, cost-effective measures to reduce methane lost through venting, flaring, and leaks. The rule will help decrease the over \$300 million in natural gas that is wasted each year from our public and tribal lands and provide up to \$800 million in royalty revenues to states, tribes, and federal taxpayers over the next decade. Additionally, the Methane Rule will reduce the methane pollution that contributes to climate change as well as hazardous air pollutants that damage the health of local communities by contributing to increased asthma attacks and other respiratory ailments. The Congressional Review Act, an extreme legislative tool, would not only overturn the current rule, but would prohibit the Bureau of Land Management from ever issuing "substantially similar" regulations in the future to reduce methane pollution from the oil and gas industry on public and tribal lands. On February 3, the House approved H.R. Res. 36 by a vote of 221-191. The pro-environment position was No. Mimi Walters voted Yes. [House Vote #78, 02/03/2017]</p>
